| Situation | Pest | Rate per 50 m ² | Rate per 1 m ² | Critical Comments |

| Lawn / Turf Areas and Gardens | Argentine Stem Weevil | 750 g | 15 g | Distribute granules evenly on the surface at the first sign of pest activity. Ensure incorporation with at least 6 mm of rainfall or overhead irrigation immediately after application. |
| | Nuisance ants and nesting ants | 600 g | 12 g | Nuisance ants and nesting ants: An initial application should be broadcast applied over the affected areas. As the initial numbers of active colonies is reduced, applications should shift to targeting active mounds, nests and trails. Apply granules directly to the mound and in the area immediately surrounding active mounds (56.5 cm radius = 1 m ²). |

Apply Monarch G Insecticide evenly to the surface using a granular applicator or shaker pack. Avoid direct contact with foliage when applying to garden areas. Monarch G Insecticide must be incorporated with at least 6 mm of rainfall or overhead irrigation immediately after application.
